SSAHE/AC/XIII-2/2017: Approval of the Proceedings of the Board of Studies meetings held on 30/05/2017 -Clinical - Medicine, Surgery -30/05/2017 and Allied subjects) & 29/05/2017 (Pre & Para Clinical Subjects)

Note (1): Extract of Minutes of Pre-Clinical Board of Studies meeting held on 29/05/2017 at 11.00 AM

(1). Fast-Track Examination for the repeaters: Fast-Track exam for the repaters within span of minimum 60 days and maximum 90 days from the date of announcement of results. The Board discussed the matter in detail and concluded that the schme can be implementated after one year with proper and prior preparation.



- (2) Innovations in teaching methods: Integrated teaching among Pre-Clinical subjects, it was suggested by the board that with present curriculm there is disparity in teaching hours and teaching approach among the different departments. Complete integration is not feasible but can be introduced where ever possible. It was also suggested that certain topics can be identified and modules can be prepared for the same with integration for the whole course and can be introduced periodically at different stages of the course. Z to A technique, the other innovative methods of teaching, can be implemented as and when possible after motivating the students to participate actively.
- (3).MCQ's in University Examination: MCQ's exam will be conducted for 20% of marks in each paper during university examination from this academic year. It was suggested that a question paper bank should be developed rather than question bank.

\underline{Note} (2): Extract of Minutes of Para-Clinical Board of Studies meeting held on $\underline{29/05/2017}$ at $\underline{2.00}$ PM

(1). Introducing tutorials at the end of the term to prepare them for the university exams in

parallel with classes instead of end of each term.

(2). Assessment for UG students can be predefined like seminar, Poster, cases, etc before the start of the term along with regular writing exam. Continuous Internal assessment should be preferred over period internal assessment.

(3) Animals for experimentation in the Hospital and in the departments of the

constituent colleges. No research work is carried out using animals.

The Deemed Universities came under the scanner in 2009 following an adverse report by a government panel and uncertainty on their status has contined since then. Eight years back, MHRD set up the Tandon Committee to examine 126 deemed universities. The committee in its report found 46 of them unworthy of being given a deemed university status. Another 44 were found deficient on many counts while the performance of 38 was found satisfactory. Our university is one among 38 universities. Shortly the University Grants Commission will review 38 deemed universities.
